



## Louisiana NMA EPA Regulation Issue Survey Topline Results

Magellan Strategies are pleased to present the topline results for a 719n autodial survey of likely general election voters in the state of Louisiana. The interviews were conducted June 5<sup>th</sup> and 8<sup>th</sup>, 2014. This survey has a margin of error of +/- 3.65% at the 95 percent confidence interval. This survey was weighted based upon past general election voting demographics.

### **Survey Methodology**

This survey was conducted using automated telephone touchtone technology. The sample used for this survey was randomly drawn from a Louisiana voter file. The survey response data was weighted based upon past general election voting demographics. The interviews were conducted on June 5<sup>th</sup> and 8<sup>th</sup>, 2014. Three attempts were made to interview each household in the sample. This survey has a margin of error of 3.65% at the 95 percent confidence interval.
