Consistent with the recent CBS News/NYT survey, Pennsylvania Governor Tom Corbett has closed the gap to within 12 points.

Among voters who have definitely decided on a candidate, the race has closed to within 7 points.

Baton Rouge, LA – Magellan Strategies BR released the survey results today of an automated survey of 1,214 likely Pennsylvania voters. The survey was conducted July 30-31, 2014. The margin of error for a survey of this size is 2.83%. The survey was the commissioned by the Pennsylvania news website Keystone Report (KeystoneReport.com).

BALLOT

Corbett is within 12 points of Wolf (38.1% Corbett/50.3% Wolf/11.6% undecided). Among voters who have definitely decided on a candidate, Corbett is within 7 points (28.6% definitely Corbett/35.9% definitely Wolf/24% lean toward a candidate/12% undecided).

Wolf's lead is buoyed by his 69 point advantage among registered Democrats (80% Wolf/11% Corbett/9% undecided). Corbett, however, has yet to solidify the Republican base. Currently, he only leads among registered Republican by 42 points (64% Corbett/22% Wolf/13% undecided).

Undecided voters should break disproportionally toward Corbett. Among the 12% who are undecided, 50% are registered GOP while 36% are registered Democrat.

Another bright spot for Corbett is the fact that Wolf's favorable to unfavorable image ratio is getting closer to 1 to 1 as more voters develop an opinion of him. In the February 2014 Quinnipiac survey, Wolf had a 4.6 to 1 favorable to unfavorable ratio (42% favorable/9% unfavorable/48% no opinion). In the May 2014 PPP survey, his favorable to unfavorable ratio dropped to 2.4 to 1 (47% favorable/20% unfavorable/33% no opinion). Currently, Wolf's favorable to unfavorable ratio is 1.4 to 1 (45% favorable/32% unfavorable/22% no opinion).

ISSUES

Both candidates will close the campaign with an albatross around their neck. For Corbett, it is the issue of education spending. A majority of voters believe he has cut education spending (42% drastically cut/11.4% slightly cut). For Wolf, it is his plan to increase state income taxes. Among undecided voters, 47% would be less likely to vote for Wolf if they knew about his plan to raise state income taxes.

OTHER FINDINGS

Despite having generated \$2.7 billion in state and local tax revenue, employing 240,000 workers, lower energy cost for home owners and creating an abundant supply of clean burning fuel, somehow the Marcellus Shale has not developed into a winning issue for Corbett. Currently, voters are evenly split as to their views on the pros and cons of Marcellus Shale/Natural Gas Suppliers (40% beneficial/37% not beneficial/23% undecided). Driving these negative opinions are voters farthest from the exploration activity. In Philadelphia, the issue is upside down (33% beneficial/39% not beneficial/28% undecided).
